



2017 General Obligation (GO) Bond Transportation and Mobility Projects

Denver voters will decide on November 7, 2017, whether to approve \$937 million in borrowing over the next 10 years to pay for a variety of projects throughout the city. Here is the breakdown of the \$431 million allocated for transportation and mobility projects in the General Obligation (GO) Bond.
